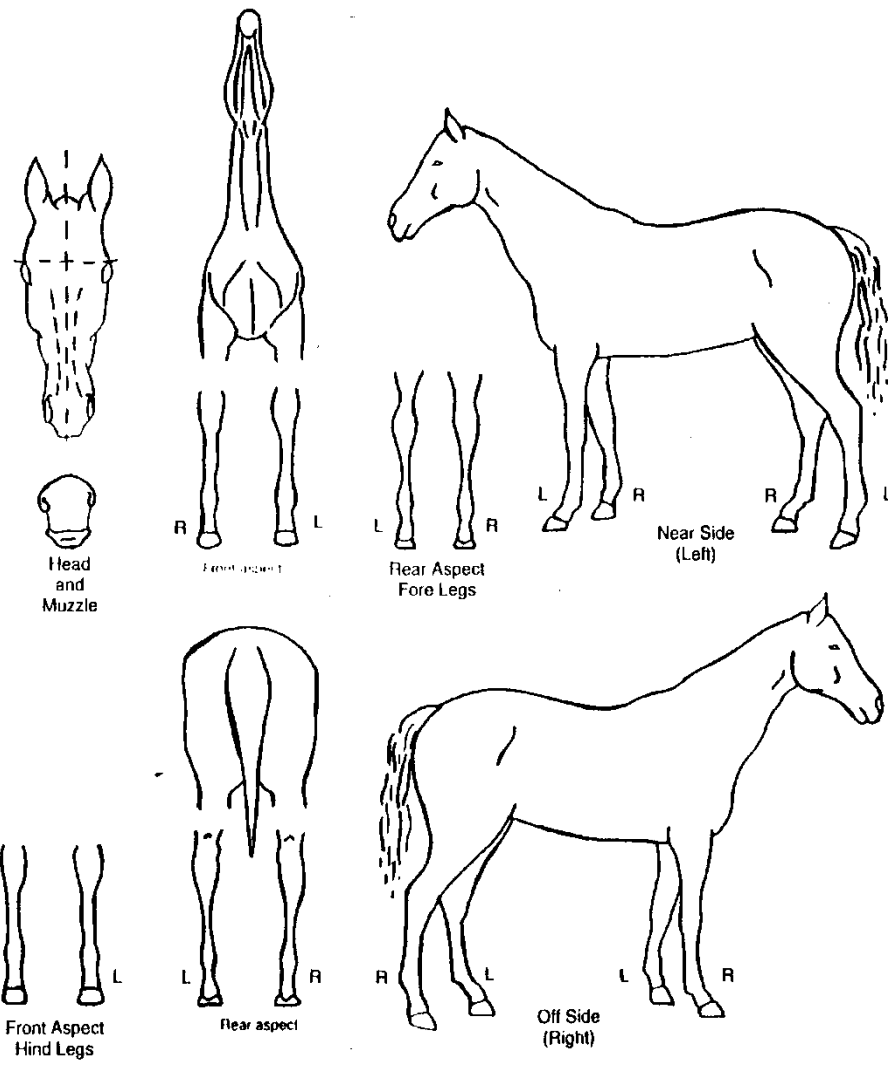
**Horses applying** for Appaloosa Pedigree Recognition (APR) Registry must supply a 5 generation pedigree with this application.

**COMPUTERISED AND INSTANT PHOTOS ARE NOT ACCEPTED.**

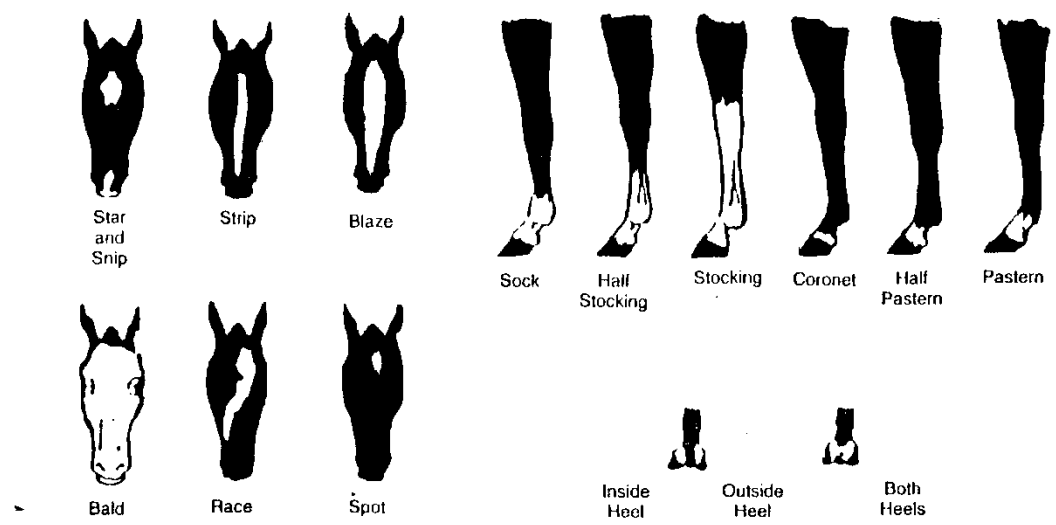
