Any horse applying for **Foal Recording** whose Sire or Dam is not a registered AAA Ltd Appaloosa, must be Outcross Recorded.

Breed Registries recognised by the AAA Ltd (refer to Rule 3.14): AJC OR ASB THOROUGHBREDS, AQHA, ASH, AHSA, AWWA – Stud Book Only

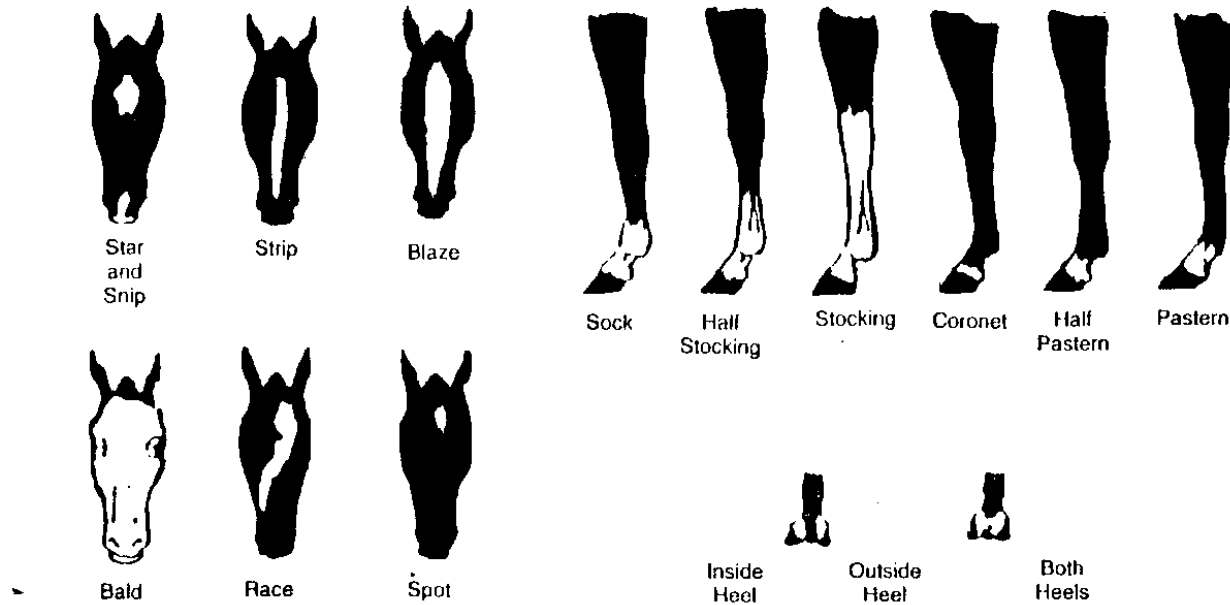
