As from 1st August 2014, any horse registered with one of our approved breed registries listed above, must be registered as an approved outcross. As from 1st August 2015 progeny bred from an outcross that is not registered **will not** be eligible for registration.

If your outcross **has been** used in Appaloosa Breeding prior to 1st August 2014, all you will need to do is complete the form and return it to the AAA Ltd Office. Should it be proven that the outcross does not meet the requirements in Rule 3.13, approval may be denied or revoked in accordance with these rules.

Any outcross that **has not been** used in Appaloosa Breeding prior to 1st August 2014, you must supply a 5 Generation Pedigree, Genetic Test Results for HYPP, HERDA & OLWS showing the applicant horse to be negative. A Genetic Test for the Grey Gene and Roan Gene may also be required, and must show the applicant horse to be negative. A copy of the applicant horses' breed registration papers must also accompany this application.

Failure to submit all necessary paperwork will result in denial of application.

When using an outcross, it is your responsibility to ensure that the horse has met the Rules of AAA Ltd Registration. A list of all Outcross Registered Stallions will be placed on our Website. Geldings are not eligible for Outcross Registration
