



## STALLION UPGRADE FORM

*Colt to Stallion inspection forms.*

*Failure to upgrade prior to breeding, penalty \$800*

The basis of this Veterinary Inspection is designed to determine the eligibility of a stallion as a registered sire for breeding.

### AGE

Colts are eligible for upgrade from 1st August in the season in which they reach two (2) years of age.

### METHOD OF UPGRADE

Colts and Stallions will be eligible for acceptance for Adult registration on the production of a signed

**Veterinarian Inspection Report (see over)** stating that the horse is: -

- NOT a Cryptorchid
- NOT a Monorchid
- NOT Parrot Mouthed
- HAS BOTH Testicles descended & evenly sized
- HAS NO visible signs of hereditary unsoundness
- THE HEIGHT of the horse must be stated

The Veterinarian Report must be accompanied by FOUR (4) coloured photographs (two near side and two off side). One of these photos must be signed by the inspecting Veterinarian. Instant and Computerised photographs will NOT be accepted.

The Progeny (colt) Recording Certificate must accompany the above.

At the time of upgrade, results of 5 panel testing must be provided as per AAA Ltd Rule 3.37

Your application must include the current registration papers.

### FEES

\$350.00 Stallion Registration (includes Certificate of Service Book).

For Stallions which have not been Progeny Recorded, a late fee of \$140.00 must be added to the above.
